THE COMMUNITY

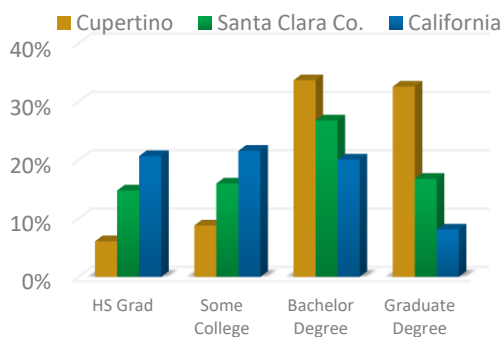

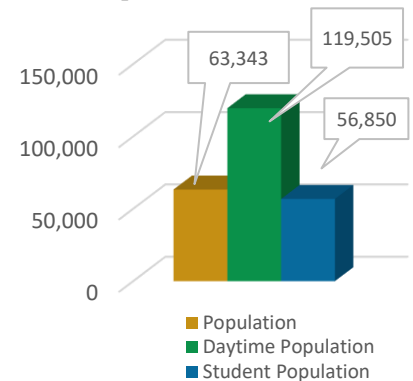

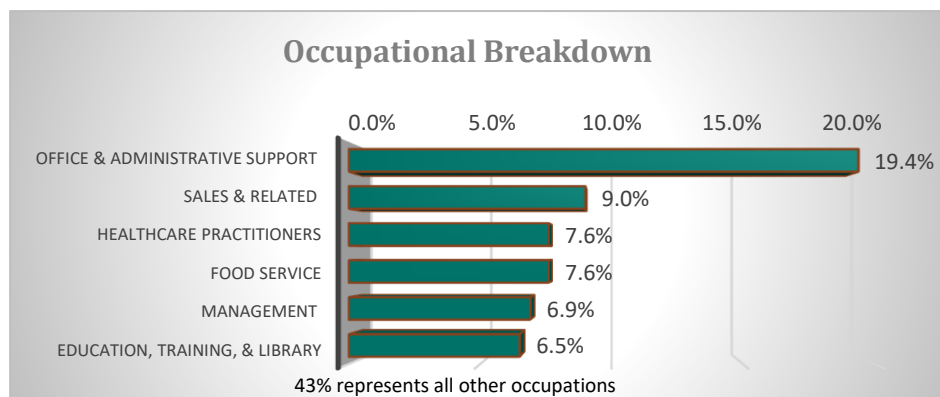


LABOR MARKET BREAKDOWN

The occupations that are located within the City of Cupertino:



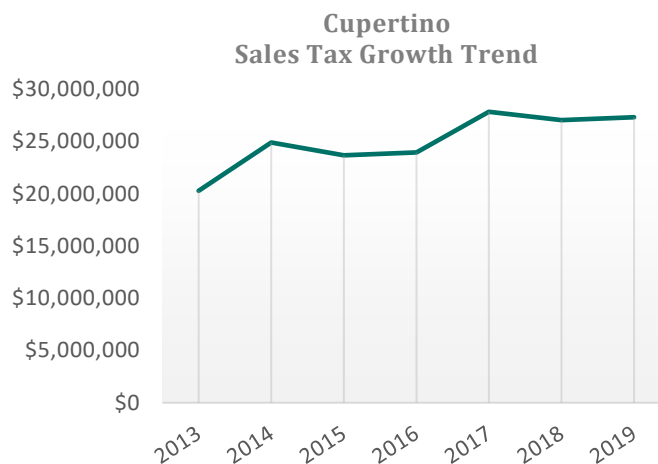

ECONOMIC INDICATORS

SALES TAX SUMMARY

Cupertino's sales tax revenues grew 35% over the period between 2013 and 2019 calendar years, which is above both the Santa Clara County and State's growth. Being located in Silicon Valley and home to major technology firms, 80% of Cupertino's total sales tax revenue is generated from the Business & Industry segment. That same segment showed a 43% growth over the comparable period.

Cupertino has seen increases in sales tax revenues from the Restaurants & Hotels sector as new local eatery options open throughout the city. With the closure of the

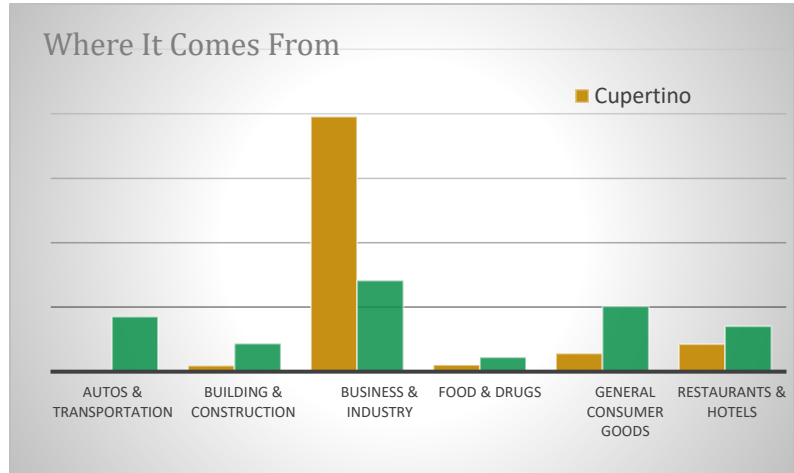
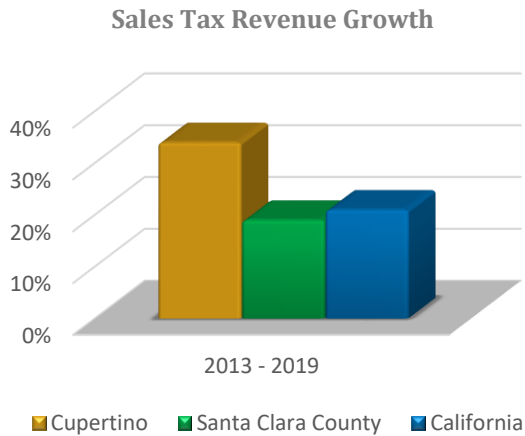

EMPLOYMENT SUMMARY

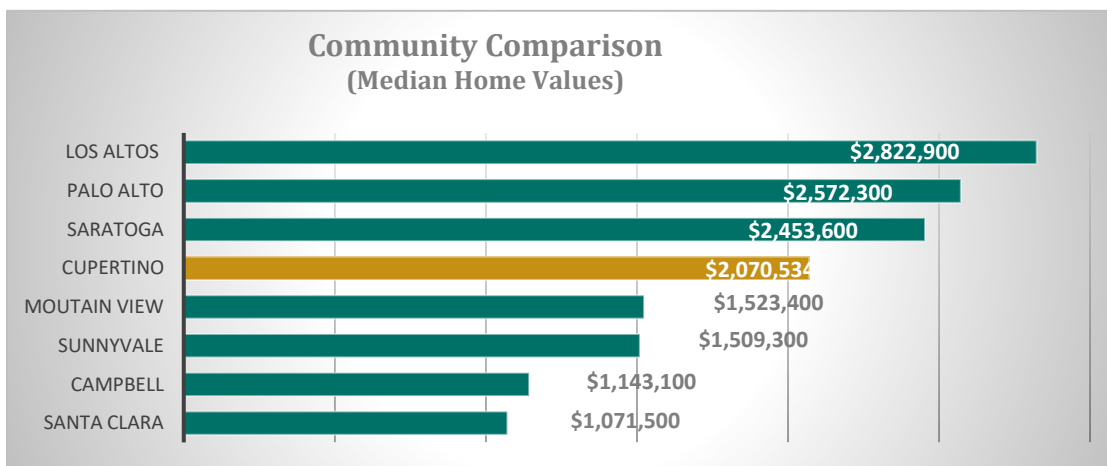
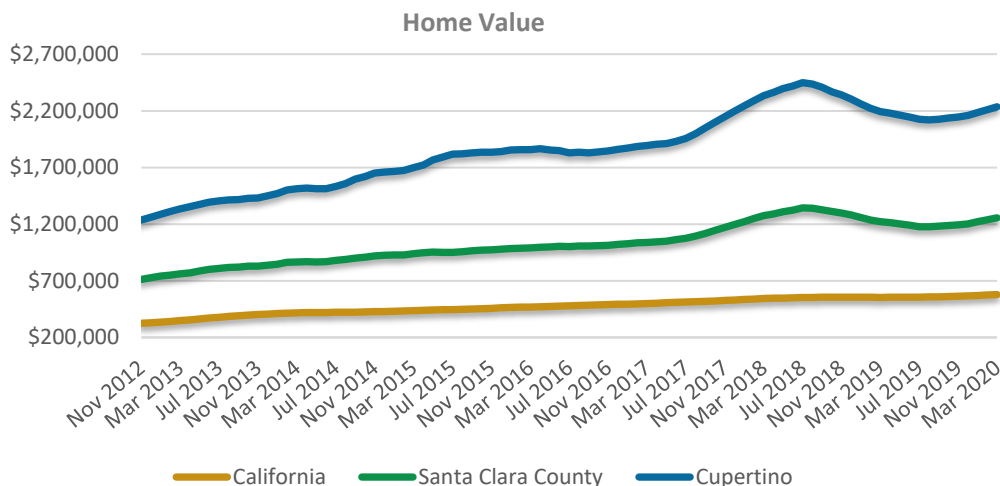
Santa Clara County has been a booming employment region in the state of California led by the clusters of successful high-tech firms and startups. The county's total civilian unemployment rates have continuously outpaced the state's year-over-year rates during the comparison period between 2012 to 2018. Unemployment reached 2.6% in 2018, down from 6.4% in 2012. Santa Clara County had a 15.7% employment growth mainly from Professional & Business Services, Information, and Health Care & Social Assistance industries.
